- (B) Students belonging to SC/ST/OBC/Divyang (PH) would be given up-gradation in aggregate by 04% for the purpose of admission to class XI.

Maximum concession under Sports/Games/NCC / Scout / Guide/Adventure will not exceed 06% Marks in aggregate. **In case of eligibility for more than one concession under different categories as mentioned at (A) and (B) above, only one concession having maximum advantage to the candidate will be allowed** (The same benefit may be extended to non-KV Students for fresh admission in KVs.)

Eligibility for different streams as per Admission Guideline of KVS (2021-22): -

1. Science Stream - A minimum of 60 % Marks in aggregate of all subjects.
2. Commerce Stream - A minimum of 55 % Marks in aggregate of all subjects.
3. Humanities Stream - All students of KV if declared passed in class X exam.
